ALL that piece, parcel or lot of land with all buildings and improvements thereon situate, lying and being on the northeastern side of Redcliffe Road in Greenville County, South Carolina, being known and designated as Lot No. 13 as shown on a plat of Pelham Estates, Section 3 made by Piedmont Engineers and Architects dated February 11, 1969, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-G at Page 13 and having according to said plat the following metes and bounds, to-wit:

EEGINNING at an iron pin on the northeastern side of Redcliffe Road at the joint front corner of Lots Nos. 12 and 13 and running thence along the common line of said lots N. 45-40 E. 212.3 feet to an iron pin; thence N. 44-58 E. 202 feet to an iron pin at the joint rear corner of lots nos. 13 and 14; thence along the common line of said lots S. 45-10 E. 212.0 feet to an iron pin on the northeastern side of Redcliffe Road; thence along the northeasten side of Redcliffe Road S.44-50 W. 200.00 feet to an iron pin, the point of beginning.
