THIS MORTGAGE is made this 13th day of July, 1979, between the Mortgagor, Bobby Joe Jones Builders, Inc. 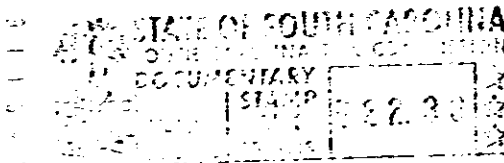
