(b) that if there is a default in any of the terms, conditions, or covernants of this mortgage, or of the note secured bereby, then, at the option of the Mortgagee, all sams then owing by the Mortgager to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
