MORTGAGE

THIS MORTGAGE is made this 23rd day of July, 1979, between the Mortgagor, Edward L. Deal, Jr. and Mary Lou O. Deal (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

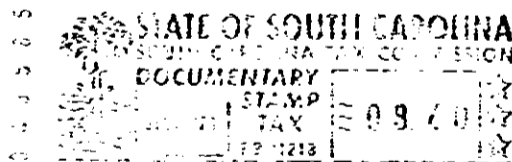
WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty One Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated July 23, 1979 (herein "Note"), providing for monthly installments of principal and interest with the balance of the indebtedness, if not sooner paid, due and payable on July 1, 2009.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of _____, State of South Carolina:

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 653 on plat of Sheet 2 of 2, Westwood, Section VI, recorded in Plat Book 5 P at page 35 and having the following courses and distances according to said plat:

Beginning at an iron pin on Buckey Court at the joint front corner of Lots 653 and 654 and running thence with the joint line of said lots, S. 1-00 E. 107.75 feet to an iron pin; thence S. 85-03 W. 62.88 feet to an iron pin; thence with the joint line of Lots 653 and 652, N. 25-25 W. 167.07 feet to an iron pin; thence with Buckey Court, N. 45-17 E. 70 feet, S. 89-52 E. 35.4 feet, S. 49-00 E. 25.9 feet, S 5-55 W. 32.8 feet and S. 27-19 E. 25.0 feet to an iron pin, the point of beginning.
