All that piece, parcel or lot of land situated in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 10 on a plat entitled Property of Darrell Waynan Wittner, dated November 11, 1971, by Carolina Surveyin g Company said plat being recorded in the R.M.C. Office for Greenville County, South Carolina, in the the Plat Book 41, at page 14, and having, according to said plat the following metes and bounds to-wit:

To provide and maintain fire insurance with extended coverage endorsement, and other insurance as Mortgagee may require, upon the building and improvements now situate or hereafter constructed in and upon said real property, in companies and amounts satisfactory to and with loss payable to the Mortgagee; and to deliver the policies for such required insurance to the Mortgagee.
- 4. In case of breach of covenants numbered 2 or 3 above, the Mortgagee may pay taxes, levies or assessments, contract for insurance and pay the premiums, and cause to be made all necessary repairs to the buildings and other improvements, and pay for the same. Any amount or amounts so paid out shall become a part of the debt secured hereby, shall become immediately due and payable and shall bear interest at the highest legal rate from the date paid.
