

ALL that certain piece, parcel, or lot of land, situate, lying and being in Greenville County, South Carolina, being shown and designated as Lot 141 on a Plat of Section 4, BRENTWOOD, recorded inthe RMC Office for Greenville County in PLat Book 5-D, at Page 43, and having, according to a more recent survey by Freeland & Associates, dated July 23, 1979, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Brentwood Way, joint front corner of Lots 140 and 141, and running thence with the common line of said Lots, S 02-13 E, 168.3 feet to an iron pin; thence with the rear line of Lot 141, with the creek as the line, the following courses and distances: N 68-42 W, 34.0 feet to an iron pin; thence S 72-02 W, 77.24 feet to an iron pin, joint rear corner of Lots 141 and 142; thence with the common line of said Lots, N 14-00 W, 172.10 feet to an iron pin on the southern side of Brentwood Way; thence with Brentwood Way, N 84-48 E, 140.72 feet to an iron pin, the point of beginning.
