"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Covington Road, being shown and designated as Lot 136, Section 3, on plat of Northwood Hills, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY, page 37, and having the following metes and bounds according to plat entitled "Property of Sidney A. Perry, Jr. and Colene F. Perry" dated July 31, 1979 by James R. Freeland, R.L.S.:
