MORTGAGE

THIS MORTGAGE is made this 6th day of AUGUST, 1979, between the Mortgagor, DAN MICHAEL OWENS, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

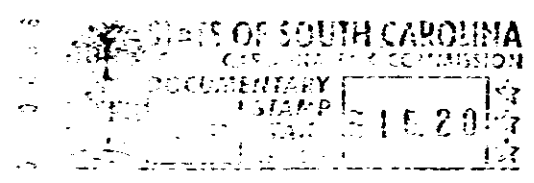
WHEREAS, Borrower is indebted to Lender in the principal sum of THIRTY EIGHT THOUSAND (\$38,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 6, 1979, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2010;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the southeast side of Route 417, as shown on plat by T. H. Walker, Jr. dated Aug. 4, 1979, containing 2 acres more or less.

Beginning at a nail in center of Route 417, near Peters Creek, and running thence with the Creek as the line, the traverse line of which is S. 56-22 E. 100 feet to a point; thence S. 68-14½ E. 45.3 feet to a point; thence S. 27-27 W. 53 feet to a point; thence S. 25-15½ W. 73.7 feet to a point; thence crossing said Peters Creek S. 45-47 E. 382.8 feet to a point in the center of Rt. 146; thence with the center of said road S. 54-37 W. 91.6 feet to a nail; thence N. 70-30 W. 193.8 feet to an iron pin; thence N. 42-45 W. 222 feet to a nail in the center of Rt. 417; thence with the center of said road N. 20-01 E. 100 feet to a point; thence continuing N. 15-05 E. 179.3 feet to the beginning corner.

This is a portion of the property conveyed to mortgagor by Clara C. Snow by deed dated March 5, 1976 recorded March 8, 1976 in deed vol. 1032 page 662 of the RMC Office for Greenville County, S. C.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
