MORTGAGE

THIS MORTGAGE is made this 9th day of August, 1979, between the Mortgagor, Donald A. Fogle and Patsy S. Fogle, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS Borrower is indebted to Lender in the principal sum of Sixty Thousand Seven Hundred and no/100 (\$60,700.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 9, 1979, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on March 1, 2010.....;

ALL that certain piece, parcel, or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 78 on plat of Brookfield West, Section I, recorded in Plat Book 7-C, at Page 19, and having such courses and distances as will appear by reference to said plat.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
