"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Oneal Township, Few's Chapel Community, shown and designated as 2.73 acres, more or less, according to survey and plat entitled "Property of Rudolph V. Hall, Sr" to be recorded in RMC Office for Greenville County in Plat Book 7M at page 47, reference to which is hereby pleaded, said plat prepared by Gould & Assoc., dated 8-4-79.
