WHEREAS,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Whereas the first payment is due on September 14th 1979 in the amount of One-
Hundred Sixty Four Dollars and No Cents (164.00) and each additional payment
being due on the 14th of each month in the amount of One Hundred Sixty Four Dollars
and No Cents (164.00) until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel of land in Butler Township, Greenville County, State of South Carolina, being designated as Tract No.1, on a plat of a portion of the property of Lee Henderson made by J. Mac Richardson, Surveyor, dated June, 1956, and being more particularly described as follows;

BEGINNING at an iron pin being the joint front corner of Tract No. 1 and the property of Ed Moseley and running thence S. 28-15 E. 680 feet to an iron pin on the line of the Robert McDaniel property; thence N. 23-30 E 85 feet to an iron pin; thence N 28-00 W. 627 feet to an iron pin on an unnamed County Road; thence S 61-30 W 67 feet to the point of beginning, said measurements extending beyond iron pins to the center of the unnamed County Road being the Northern boundary and containing one acre, more or less.
