THIS MORTGAGE is made this 16th day of August 1979, between the Mortgagor, Chris J. Mellow (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

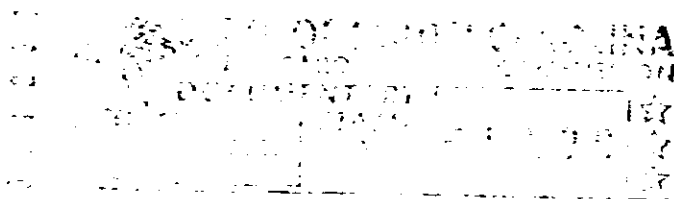
WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-Four Thousand Nine Hundred and No/100 (\$34,900.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 16, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2009.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 108 on plat of Harbor Town, recorded in the RMC Office for Greenville County, S. C. in Plat Book 5P at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the corner of Units 108 and 109 and thence running N. 39-04 E. 20.7 feet; thence turning and running S. 50-56 E. 67.6 feet; thence turning and running S. 39-04 W. 20.7 feet; thence turning and running N. 50-56 W. 67.6 feet to the point of beginning.
