ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the western side of Bedford Drive, in Greenville County, South Carolina, being shown and designated as Lot No. 33 on a plat of HEATHWOOD SUBDIVISION, made by Dalton & Neves, dated July, 1956, recorded in the RMC Office for Greenville County, S.C., in Plat Book KK, Page 35, reference to which plat is hereby craved for the metes and bounds thereof.
