MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, we, Hewey Richardson and Ruby Richardson,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as 2.0 acres on plat of Faye W. Hall as prepared by Carolina Surveying Company, dated October 2, 1978, and recorded in the R. M. C. Office for Greenville County in Plat Book 6-W, at Page 19, and having according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Fork Shoals Road and running thence N. 88-15 E., 697.0 feet to an iron pin; thence S. 1-47 W. 125.0 feet to an iron pin; thence S. 88-15 W., 697.0 feet to an iron pin on Fork Shoals Road; thence with said Road, N. 1-47 E., 125.0 feet to an iron pin, the point of beginning.
