WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by the presents does grant, bargain, sell and release anto the Mortgagee, its successors and assigns:

All that piece, parcel or lot of land lying, being and situate on the eastern side of Taylors Road near the City of Greer, being shown and designated as Lots Nos. 112 and 113 on plat entitled Belmont Heights, Inc., Section No. 2 prepared by Dalton and Neves Engineers, dated July, 1960, and having the following metes and bounds; to-wit:

BEGINNING at an iron pin on the eastern side of Taylors Road at the joint front corner of Lot 112 and property owned by S. W. Taylor and running thence along the eastern side of Taylors Road N. 7-42 E., 215 feet to an iron pin; thence S. 78-14 E., 234.2 feet to an iron pin at the joint rear corner of Lots Nos, 113 and 114 as shown on the aforesaid plat; thence running S, 7-07 W, 280 feet to an iron pin; thence N. 63-09 W., 250 feet to the beginning point,

This being the same property conveyed to Lecil D. Wilbanks by deed of E. R. Taylor recorded in the RMC Office for Greenville County on April 19, 1973 in Deed Book 971 at Page 837. Lecil D. Wilbanks conveyed a one-half undivided interest unto Linda Wilbanks by deed recorded on July 8, 1975 in Deed Book 1020 at Page 887.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household turniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in tee simple absolute, that it has good tight and is playfully authorized to sell, convey or encumber the same, and that the premises are tree and clear of all liens and encumbrances except as provided therein. The Mortgagor further covenants to warrant and forever detend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereot.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the Oppayment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also Osecure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgage unless otherwise provided in writing.

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and that it will pay all premiums by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.

(3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs necessary, including the completion of any construction work underway, and charge the expenses for such repairs of the completion of such construction to the mortgage debt.
