TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE, made this 11th day of September, 1979, by Boyce Stamey and Betty F. Stamey hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

WHEREAS, the said Mortgagor is truly indebted unto UNITED VIRGINIA MORTGAGE CORPORATION, Richmond, Virginia, hereinafter called the Mortgagee, in the sum of Five Thousand Nine Hundred Sixty & No/100 (\$ 5,960.00) Dollars, as evidenced by a promissory note of even date herewith, payable to the order of the Mortgagee in 120 consecutive monthly instalments of Eighty-Seven and 24/100----- (\$ 87.24) Dollars each, the first instalment being due October 15, 1979, and the remaining instalments are due on the 15th day of each month thereafter.

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, known and designated as all of the following portion of Lot Number 10 as shown on plat of the property of G. D. Oxner, recorded in the RMC Office for Greenville County in Plat Book G, at Page 42, and described as follows:

BEGINNING at an iron pin on the Southwest side of Laurel Street, the joint front corner of Lots 9 and 10, and running thence with the line of Lot No. 9, S. 33-54 W. 86.6 feet; thence running through Lot No. 10, S. 55-54 E. 50 feet to an iron pin in line of Lot No. 11; thence along the line of Lot No. 11, N. 33-54 E. 88.4 feet to an iron pin on the Southwest side of Laurel Street; thence with the Southwest side of Laurel Street, N. 55-54 W. 50 feet to the beginning corner.
