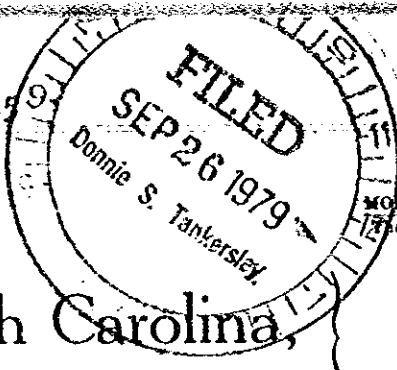

 situate, lying and being on the Eastern side of Gayle Street in Gantt Township,  
 Greenville County, South Carolina, being shown and designated as Lot No. 45 and a  
 portion of Lot No. 46 on a Plat of ROCKVALE, Section 1, recorded in the RMC Office for  
 Greenville County, S.C., in Plat Book QQ, at Page 108, and having according to a plat  
 of the Property of Joe E. Prowell and Lynda H. Prowell made by Carolina Surveying Co.,  
 dated August 24, 1977, the following metes and bounds, to-wit:
