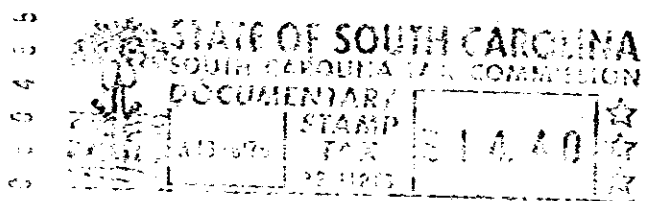
THIS MORTGAGE is made this 6th day of August, 1979, between the Mortgagor, Richard Dale Vaughan and Deborah C. Vaughan (herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

All that certain piece, parcel or lot of land with all improvements thereon on hereafter constructed thereon, situate, lying and being on the southern side of Amy Lane, near the City of Greenville, in the County of Greenville, State of South Carolina, being known as Lot Number 220 of a subdivision known as Colonial Hills, plat of which is recorded in Plat Book WW at Pages 12 and 12 of the RMC Office for Greenville County; reference to said plat being craved for the exact metes and bounds thereof.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
