with interest thereon from date at the rate of 13.50% per centum per annum, to be paid:

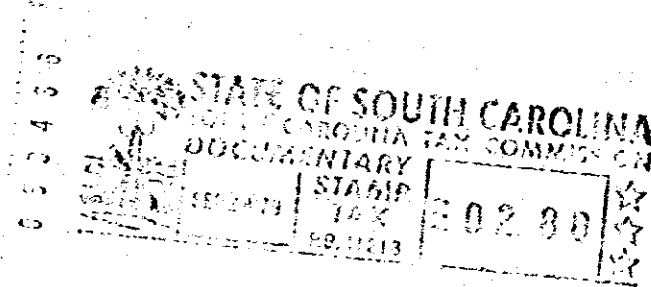

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the northeastern side of Valeview Circle, in Greenville County, South Carolina, being shown and designated as Lot No.7 on a plat of MARIETTA HEIGHTS, made by Terry T.
