ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Southern side of W. Augusta Drive, being known and designated as Lot No. 92 and part of Lot No. 91 on Plat of "Augusta Circle" prepared by R. E. Dalton, recorded in the RMC Office for Greenville County, S.
