Amount advanced \$9,214.99

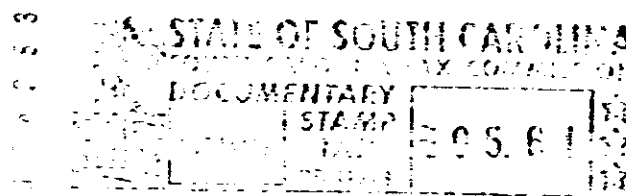
