TO ALL WHOM THESE PRESENTS MAY CONCERN: Waymond L. Burton

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co., Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Forty-two Thousand Six Hundred Seventy-seven & 40/100 DOLLARS (\$42,677.40 ),  
with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid: in 60 equal monthly installments of \$711.29 each, the first of said installments being due December 1, 1979, and a like payment due on the first day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

Amount advanced \$28,010.80.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lots numbered 7 and 8 on plat of the Mary Leake Estate property as recorded in Plat Book 5-D at Page 22 of the RMC Office for Greenville County.

This is the same property conveyed to the mortgagor by deed of Ray W. Reid dated September 26, 1974 and recorded September 27, 1964 in Deed Book 1007 at Page 433 of the RMC Office for Greenville County; and by deed of A.E. Green, et al, recorded March 19, 1974 in Deed Book 995 at Page 586, RMC Office for Greenville County.
