TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Cathedral of Faith, Inc.

(hereinafter referred to as Mortgagor) is well and truly indebted unto H. W. Morrison

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Seven Thousand Five Hundred and Eighty----- Dollars (\$ 7,580.00) due and payable

in equal monthly installments of Two Hundred Fifty Dollars (\$250.00) including interest.

with interest thereon from Oct. 16th at the rate of 9% per centum per annum, to be paid: the 16th of each month thereafter until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Bates Township near Travelers Rest, South Carolina and having the metes and bounds as shown on a plat of H. W. Morrison recorded in the R.M.C. Office for Greenville County in Plat Book 7-R, Page 57 containing 5.79 acres.

This being the same property conveyed to the Mortgagors by deed of H. W. Morrison and Eliza H. Morrison by deed recorded October 19, 1979 in Deed Book 1113 at page 863.
