ALL that certain piece, parcel or lot of land situate on the southern side of East Park Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 16 on plat of the W. C. Cleveland Property, recorded in Plat Book B, at Page 11, and being more particularly described as follows:

BEGINNING at an iron pin on the southern side of East Park Avenue, joint front corner of Lots 15 and 16, and running thence with the southern side of East Park Avenue, S. 63-01 E., 70 feet to pin at the corner of Lot 17; thence with line of Lot 17, S. 26-59 W. 161 feet to pin; thence S. 81-29 W. 86 feet to pin at corner of Lot 15; thence with line of Lot 15, N. 26-59 E. 211.2 feet to the point of beginning.
