ALL that here, parcel or lot of land, together with buildings and improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina in Butler Township on the western side of Roger Mountain Road, containing 1.00 acres according to a plat filed by S.C. Public Land Survey, 1966 and being, according to said plat, the following parcel or parcels, to-wit:

AND IT IS AGREED, by and between the said parties, that the said Mortgagor, his heirs, executors or administrators, shall and will forthwith insure the house and building on said lot, and keep the same insured from loss or damage by fire in at least such sums as the Mortgagee shall from time to time require and assign the policy of insurance to the said Mortgagee, its successors or assigns.
