Sheet 88, Block 1, Lots 12.1, 16 and 17:

BEGINNING at an iron pin on the southwestern side of University Street at the joint front corner of Lots Nos. 30 and 31 as shown on the County Tax Maps at

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
