WHEREAS, the Mortgagor is well and truly indebted unto **Associates Financial Services Co Inc**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-three Thousand Nine Hundred Forty-eight and DOLLARS (\$23,948.18), with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid: in one monthly installment of \$293.18 each, due December 12, 1979 and 95 equal monthly installments of \$249.00 each, the first of which shall be due January 12th, 1980 and a like installment due on the 12th day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.
