WHEREAS, the Mortgagor is well and truly indebted unto

State of South Carolina: being shown and designated as Lot 76 on a Plat of DIXIE HEIGHTS, recorded in the RMC Office for Greenville County in Plat Book H, at Page 46. Said Lot fronts 50.0 feet on the southeastern side of Dixie Avenue; runs back to a uniform depth of 150.0 feet, and has 50.0 feet across the rear.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
