SEND GREETINGS:

Whereas, I, we the said Clyde L. Wooten and Donna G. Wooten hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Simpsonville, S. C., hereinafter called Mortgagee, the sum of 7,173.58 plus interest as stated in the note or obligation, being due and payable in 60 equal monthly installments commencing on the 5th day of December, 1979, and on the same date of each successive month thereafter.

All that lot of land with the buildings and improvements thereon situate on the north side of Seminole Drive, near the Town of Simpsonville, Austin Township, Greenville County, South Carolina, being shown as Lot No 47 on Plat of Section 1 of Westwood Subdivision, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4-F at Page 21 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Seminole Drive at the joint corner of Lots Nos. 46 & 47 and runs thence along the line of Lot No. 46N. 0-03 E 150.85 feet to an iron pin; thence along the line of Lot No. 45 S. 89-33 W. 100 feet to an iron pin; thence along the line of Lot No. 48 S. 0-06 W 150 feet to an iron pin on the north side of Seminole Drive; thence along Seminole Drive S. 89-56 E. 100 feet to the beginning corner.
