WHEREAS, We, BOBBIE J. MURRAY

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the south-eastern side of Mt. Creek Road (formerly Sandy Flat Road), and known and designated as a major portion of Lot No. 5 of a subdivision of property of D. L. Chandler; also shown as the property of James Leonard Douglas by plat prepared by Carolina Engineering & Surveying Co. recorded in the RMC Office for Greenville County in Plat Book 4H, at page 1; said lot having such metes and bounds as shown on said latter plat.
