State of South Carolina; being shown and designated as Lot 232 on a Plat of Robert J. Edwards Property, recorded in the RMC Office for Greenville County in Plat Book EE, at Page 61. Said Lot fronts 100.0 feet on the western side of Elizabeth Drive; runs back to a uniform depth of 200.0 feet, and has 100.0 feet across the rear.

This is the same property conveyed to the Mortgagors herein by deed of Gilbert E. Carlson and Linda E. Carlson, dated November 21, 1979, to be recorded simultaneously herewith.
