ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, M. Kemp Younts, Jr.,

(hereinafter referred to as Mortgagor) is well and truly indebted unto The Palmetto Bank, Weston Street, Fountain Inn, S. C.,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty Thousand and No/100 Dollars (\$40,000.00) due and payable

One year from date

with interest thereon from date at the rate of twelve per centum per annum, to be paid: quarterly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

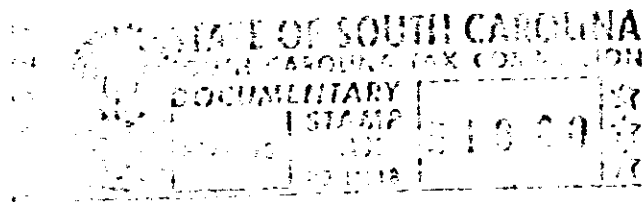
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Fountain Inn, being Lot 44 and a part of Lot 43 and 45 in accordance with plat of Belmont Heights made by Carolina Surveying Co. dated December 4, 1979, and a more recent plat dated November 20, 1978 prepared by J. L. Montgomery, III, referring to above plat, showing bearings and distances, and said property being more fully described in accordance with said recent plat, to-wit:

BEGINNING at an iron pin on the Southern side of Belmont Drive, said pin being 50 feet from the dividing line of Lots 43 and 42, and running thence along Belmont Drive, S. 62-0 E. 200 feet to an iron pin; thence S. 28 W. 200 feet to an iron pin; thence N. 62-0 W. 200 feet to an iron pin; thence N. 28 E. 200 feet to an iron pin, being the point of beginning.

This being a portion of the property as conveyed to the mortgagor by deed of Sara A. Patton recorded in the RMC Office for Greenville County in Deed Book 1113, Page 211, recorded October 8, 1979.
