WITNESS the Mortgegor's hand and seal this SIGNED, sealed and delivered in the presence of:

(1) That this mortgage shall secure the Mortgagee for such fur ther sums as may be advanced hereafter, at the option of the Mortgage, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
