Greenville County, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

ALL that certain piece, parcel or lot of land situate, lying and being in the Town of Simpsonville, County of Greenville, State of South Carolina, on the northern side of Capewood Road and being known and designated as Lot No. 290 on plat of Section No. 4, WESTWOOD Subdivision, recorded in the RMC Office for Greenville County in Plat Book 4-R at Page 30 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
