WHEREAS, the Mortgagor is well and truly indebted unto Charter Mortgage Company

ALL those certain pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the northern side of Crosby Lane and being known and designated as Lots Nos. 2 and 3 of the subdivision known as BLUE SKY PARK, Block C, on a plat thereof prepared by C. C. Jones, dated June, 1948, and recorded in the RMC Office for Greenville County in Plat Book S at Page 83 and being shown on a more recent plat entitled "Property of Richard G. Lowe and Jill M. Lowe", prepared by Carolina Surveying Company, dated December 17, 1979, and recorded in the RMC Office for Greenville County in Plat Book 7-5 at Page 97, and having such metes and bounds as shown on the more recent plat, reference to which is hereby made for a more complete description.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
