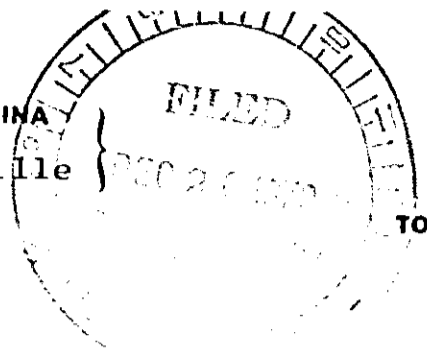

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 11 of Block "D" on a plat of Riverside, recorded in the R.M.C. Office for Greenville County in Plat Book A at pages 322-323, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the south side of Edgemont Avenue, joint corner of Lots Nos. 10 and 11, and running thence along with line of lot No. 10, 125 feet to an iron pin on a 15 feet alley; thence with the north side of said alley 64 feet to an iron pin on the west side of Sumter Street; thence with the west side of Sumter Street 125 feet to an iron pin on the corner of Edgemont Avenue and Sumter Street; thence with Edgemont Avenue in a Westerly direction 64 feet to the BEGINNING corner.

This lot contains a five-room frame house.
