TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, RICHARD LEE BERNARDE and MARLENE L. BERNARDE

with interest thereon from date at the rate of 10% per centum per annum, to be paid: Monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, with improvements thereon or hereafter constructed thereon, being known and designated as Lot Number 6, of Cannon Estates, Section 11., containing 2.03 acres more or less, according to a plat prepared by Charles K. Dunn and T. Craig Keith, R.L.S., dated February 8, 1979, and being recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book 7 C at page 14, and having according to said plat the following metes and bounds to-wit:

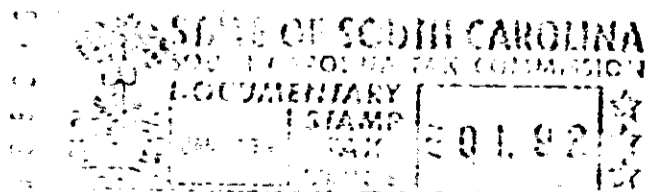
BEGINNING at the joint front corner of Lots 5 and 6 on Artillery Court and running thence along Artillery Court, N. 77-15 W. 25 feet; thence continuing along Artillery Court, W. 83-04 W. 185.53 feet to the joint front corner of Lots 6 and 7, thence with the joint line of Lots 6 and 7, N. 08-46 E. 307.53 feet to the joint rear corner of said lots; thence with the property of James R. Huff, N. 89-41 E. 338 feet to the joint rear corner of Lots 5 and 6; thence S. 27-51 W. 377.42 feet to the beginning corner.

This conveyance is made subject to recorded Restrictions in Greenville County in Deed Book 1088 at page 7 and to a joint agreement between Jack Huff and Leroy Cannon dated January 10, 1979 as to the rear property line and any other recorded easements and rights of way and any visible on the property.

This being a portion of the same property conveyed unto Leroy Cannon Realty Inc. by Master's deed recorded in the R.M.C. Office for Greenville County, S. C. in Deed Volume 1086 at page 985, and being recorded 9/8/78.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
