MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Heyward R. McConnell

(hereinafter referred to as Mortgagor) is well and truly indebted unto Ruth Schroder Means, whose address is Route #4, Travelers Rest, S.C., 29690,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about three and one-half miles west of Greenville County Courthouse, near the Southern Railway, known as Lot D on plat of survey of the lands of the Estate of Ansel Arnold, deceased, made pursuant to an order of the Court, by F.G. Rogers, Surveyor, August 2, 1911, and having, according to a plat of the property of J. E. Means made by W.J. Riddle, Surveyor, February 1946, the following metes and bounds, to-wit:

BEGINNING at a stake on the right of way of G. S. & A. Railway and running thence N. 81 W. 440 feet to a stake on a street; thence with the eastern side of said street N. 11-0 W. 81.3 feet to an iron pin; thence with the line of property now or formerly of Archie Means S. 81 E. 400 feet to an iron pin; thence S. 11 E. 81.3 feet to the point of beginning.
