

The words "you" and "your" refer to Mortgagors. The words "I," "me" and "my" refer to all Mortgagors indebted on the note secured by this mortgage.

To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville. All that certain piece, parcel or lot of land, with the improvements thereon, lying and being and situate in the County of Greenville, State of South Carolina, Austin Township, near the Town of Simpsonville, being known and designated as Lot No. 24 on Plat of Eastview Heights made by C.O. Piddle June, 1959 and being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin on the western side of Eastview Drive, joint front corner lots No. 24 and 25 and running thence along lot No. 25 S. 79-02 W. 150 feet to an iron pin; thence S. 10-58 E. 156.7 feet to iron pin; thence S. 22-0 E. 144.7 feet to iron pin; thence N. 13-0 150 feet to iron pin; thence N. 30-31 E. 99.4 feet to iron pin, being the point of beginning.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

I will pay all taxes, fees, assessments, obligations, encumbrances and any other charges against the real estate and maintain insurance on the real estate in your favor in a form and amount satisfactory to you. If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
