TO ALL WHOM THESE PRESENTS MAY CONCERN:

in 240 equal, consecutive monthly installments of \$176.50, beginning
February 15, 1980, and continuing thereafter until paid in full

with interest thereon from _____ date at the rate of 8% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 17 on a Plat of LAKE HARBOR, recorded in the RMC Office for Greenville County in Plat Book MM, at Page 15, and having, according to a more recent survey by Freeland & Associates, dated December 6, 1979, the following metes and bounds:

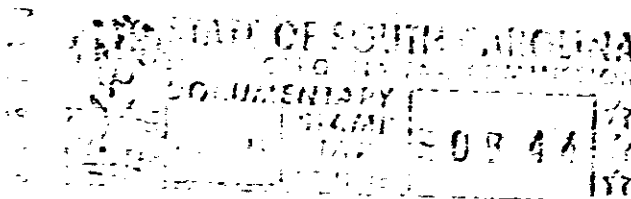
BEGINNING at an iron pin on the southeast side of Harbor Drive at the joint front corner of Lots 17 and 53, and running thence with the common line of said Lots, S 39-41 E, 275.1 feet to an iron pin; thence with the rear line of Lot 17, S 29-33 W, 127.6 feet to an iron pin, joint rear corner of Lots 16 and 17; thence with the common line of said Lots, N 29-57 W, 319.8 feet to an iron pin on the southeast side of Harbor Drive; thence with Harbor Drive, N 48-58 E, 32.8 feet to an iron pin; thence continuing with Harbor Drive, N 42-19 E, 32.2 feet to an iron pin, the point of beginning.
