TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert H. McAlister and  
Mary Louise C. McAlister (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Virginia Johnson Tribble  
(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Nine Thousand Five Hundred and no/100 ----- DOLLARS (\$ 9,500.00 ),  
with interest thereon from date at the rate of 10 per centum per annum, said principal and interest to be repaid: In monthly installments of One Hundred Fifty-seven and 72/100 (157.72) Dollars each commencing on February 15, 1980 and a like payment on the same day of each month thereafter until paid in full.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville and being shown on the eastern side of Lavinia Avenue, designated as the western portion of Lot No. 39 on Plat of the Rowley Place, recorded in Plat Book C at page 5 and being described more particularly, to-wit:

BEGINNING at a stake on the eastern side of Lavinia Avenue at the joint front corner of Lots 38 and 39 and running thence along said avenue N 24-45 W, 56 feet 6 inches to the joint front corner of Lots 39 and 40; thence along the common line of said lots in a northeasterly direction 150 feet to a corner (second stone wall); thence along said stone wall in a southerly direction 57 feet more or less to a corner on the line of Lot No. 38; thence along the common line of Lots 38 and 39 in a westerly direction, 150 feet more or less to the point of beginning.
