"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All those pieces, parcels or lots of land, together with all buildings and improvements, situate, lying and being on the northern side of Pleasant Ridge Avenue, at the intersection thereof with Penrose Avenue, in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lots Nos. 87 and 88, on a plat of PLEASANT VALLEY, made by Dalton & Neves, Engineers, recorded in the REC Office for Greenville County, SC, in Plat Book P, page 88, reference to which is hereby craved for the metes and bounds thereof.

The above property is the same property conveyed to Edward Lee Parr by deed of E R Griffin recorded in Deed Book 427, page 253 and is hereby conveyed subject to rights of way, easements, setback lines, restrictions, public roads and conditions reserved on plats and other instruments of public record and actually existing on the ground affecting said property.
