THIS MORTGAGE is made this 25th day of January, 1980, between the Mortgagor, Stephen H. Kitterman and Catherine H. Kitterman (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FORTY-SIX THOUSAND FIVE HUNDRED FIFTY and 00/100 (\$46,550.00) Dollars, which indebtedness is evidenced by Borrower's note dated January 25, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on February 1, 2010.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 8, as shown on a plat of the subdivision of HUNTERS POINTE, which is recorded in the R.M.C. Office for Greenville County, S.C. in plat book 7-C at page 35, and having according to a more recent survey by Freeland & Associates dated January 23, 1980, the following metes and bounds, to-wit:

BEGINNING at iron pin on the southeastern side of Setters Court, the joint front corners of Lots No. 7 and 8 and running thence with the joint line of said lots, S. 40-38-45 E. 123.05 feet to an iron pin in line of property now or formerly of Lucille B. Ellison; thence with the line of said property, S. 31-41-03 W. 113.07 feet to an iron pin in line of property now or formerly of Juster Enterprises; thence with said line, N. 55-45-02 W. 130.99 feet to an iron pin joint rear corner of Lots No. 8 and 9; thence with the joint line of said lots, N. 19-21-15 E. 113.51 feet to an iron pin on the southwestern side of Setters Court; thence with the curve of Setters Court, the chord of which is N. 80-02 E. 50.65 feet to the point of beginning.
