All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot 133 on a plat of Brentwood, Section III, which is recorded in the RMC Office for Greenville County in Plat Book 5-D, Page 42, and having, according to a more recent plat of Lot 133, Brentwood, Section III, prepared by Richard D. Wooten, Jr., dated January 28, 1980, the following metes and bounds, to-wit:
