WHEREAS, We, Albert Ray Tollison and Joyce H. Tollison

(hereinafter referred to as Mortgagor) is well and truly indebted unto Charles H. Cely, Trustee

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight Thousand & no/100---

Dollars (\$ 8,000.00) due and payable

in equal monthly installments of One Hundred and Five (\$105.73) & 73/100 Dollars, the first installment to be due and payable on April 1, 1980, and a like installment to be due on the first day and each and every month thereafter until this indebtedness is paid in full after ten years, with interest thereon from date at the rate of ten per centum per annum, to be paid: provided, however, that the mortgagors shall have the right to pay off this indebtedness at any time.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Dunean Mills Village, and being more particularly described as Lot No. 77, Section 6, as shown on a plat entitled "Subdivision for Dunean Mills, Greenville, S. C." made by Pickell & Pickell, Engineers, Greenville, S. C. on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the RMC Office for Greenville County in Plat Book S, at Pages 173-177, inclusive. According to said plat, the within described lot is also known as No. 21 Gallon Street (Avenue) and fronts thereon 58.5 feet.
