WHEREAS, the Mortgagor in and by his certain promissory note in writing of even date herewith is well and truly indebted to the Mortgagee in the full and just sum of Three Thousand, Five Hundred Fifty Three & 61/100 \$3553.61), with interest from the date of maturity of said note at the rate set forth therein, due and payable in consecutive installments of \$ 1x\$75.61, 47x\$74.00 each, and a final installment of the unpaid balance, the first of said installments being due and payable on the 26th day of March, 1980, and the other installments being due and payable on

All that piece, parcel or lot of land situate, lying and being on the northwestern side of Bradley Boulevard in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 87 on plat of University Park, prepared by Dalton & Neves, Engineers, dated November 1946, recorded in Plat Book P at Page 127 and being described, according to said plat, more particularly, to-wit:

Beginning at an iron pin on the northwestern side of Bradley Boulevard at the joint front corner of Lots 86 and 87 and running thence along said boulevard S. 52-26 W. 75 feet to an iron pin at the joint front corner of Lots 87 and 88; thence along the common line of said lots N. 37-34 W. 254.1 feet to an iron pin at the joint corner of Lots 87 and 126 on the southern side of Brookside Circle; thence along said circle N. 77-34 E. 82.85 feet to an iron pin at the joint rear corner of Lots 86 and 87; thence along the common line of said lots S. 37-34 E 218.6 feet to an iron pin on the northwestern side of Bradley Boulevard, the point of beginning.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, or that hereafter may be erected or placed thereon.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagor, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. To pay all sums secured hereby when due.
2. To pay all taxes, levies and assessments which are or become liens upon the said real estate when due, and to exhibit promptly to the Mortgagee the official receipts therefor.
3. To provide and maintain fire insurance with extended coverage endorsement, and other insurance as Mortgagee may require, upon the building and improvements now situate or hereafter constructed in and upon said real property, in companies and amounts satisfactory to and with loss payable to the Mortgagee; and to deliver the policies for such required insurance to the Mortgagee.
4. In case of breach of covenants numbered 2 or 3 above, the Mortgagee may pay taxes, levies or assessments, contract for insurance and pay the premiums, and cause to be made all necessary repairs to the buildings and other improvements, and pay for the same. Any amount or amounts so paid out shall become a part of the debt secured hereby, shall become immediately due and payable and shall bear interest at the highest legal rate from the date paid.
