MORTGAGE

THIS MORTGAGE is made this 14th day of MARCH 1980, between the Mortgagor, ROBERT N. WILLIAMS AND MARJORIE K. WILLIAMS (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of SEVENTY THOUSAND TWO HUNDRED AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated MARCH 14, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on APRIL 1, 2010

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE State of South Carolina:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville and being known and designated as Lot No. 342 in a Plat of Botany Woods, Section VII, recorded in Plat Book YY at Pages 76 and 77, R.M.C. Office, Greenville County, South Carolina and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Cherokee Drive at the joint front corner of Lots Nos. 341 and 342 and running thence with said Drive S. 42-05 E. 89.2 feet to a point; thence continuing S. 32-49 E. 20.8 feet to a point; thence running S. 57-11 W. 200 feet to a point; thence running N. 32-49 W. 47.7 feet to a point; thence continuing N. 49-00 W. 34.5 feet to a point; thence running N. 49-00 E. 196.9 feet to the point of beginning.
