MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Billy E. Wilburn,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Levis L. Gilstrap,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

SIX HUNDRED THIRTY AND NO/100 - - - - - Dollars (\$ 630.00) due and payable

on or before the first day of September, 1980.

with interest thereon from date at the rate of nine per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, on the northeast side of Lowndes Hill Road, being the Eastern one-half of Lot No. 108 according to plat No. 3, property of Overbrook Land Company and Woodville Investment Company made by R. E. Dalton, Engineer, January, 1924, recorded in the RMC Office for Greenville County, S. C., in Plat Book F, at Page 218, and being more particularly described as follows:

BEGINNING at an iron pin on the northeast side of Lowndes Hill Road, at the joint front corner of Lots Nos. 107 & 108; thence N. 60-34 E. 90.4 feet to an iron pin; thence, N. 33-08 W. 65 feet to an iron pin; thence, S. 61-35 W. 96.5 feet to an iron pin on the said Lowndes Hill Road; thence along said road S. 38-0 E. 67.5 feet to the beginning.

This is the same property conveyed to the Mortgagor by deed of Perrin H. Wilburn and Willie Frances Wilburn, January 19, 1959 as recorded in the RMC Office for Greenville County in Deed Book 615, at Page 175.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
