MORTGAGE OF REAL ESTATE  
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Jesse Arnold Burks and Miriam Hudson Burks

(hereinafter referred to as Mortgagor) is well and truly indebted unto Jimmie W. Capel and Vickie H. Capel

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand and NO/100-----

-----Dollars (\$ 10,000.00 ) due and payable at the rate of \$120.02 per month beginning one (1) month from date and continuing each month thereafter with entire balance due and payable in full seven (7) years from date with payments applied first to interest and balance to principal, together

with interest thereon from date at the rate of twelve per centum per annum, to be paid monthly.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as 2.47 acres on a plat entitled "Survey for W. H. Stroud", prepared by W. R. Williams, Jr., P.E./L.S., dated August 15, 1977, and recorded in the RMC Office for Greenville County in Plat Book 6-E at Page 59 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
