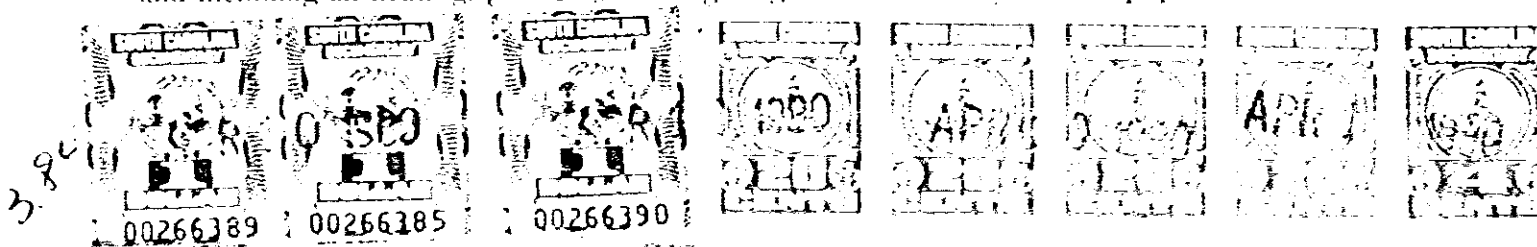
"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 68 as shown on a plat of the subdivision of White Horse Heights, recorded in the RMC Office for Greenville County in Plat Book BB, Page 183 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Range View Drive which iron pin is the joint iron corner of Lot Nos. 67 and 68 and running thence N. 48-52 E. 175 feet to an iron pin; thence S. 41-08 E. 71.7 feet to an iron pin; thence S. 37-02 W. 180.2 feet to an iron pin on the northeasterly side of Range View Drive; thence along the northeasterly side of RangeView Drive, N. 41-08 W. 108.5 feet to an iron pin, the point of beginning.
